

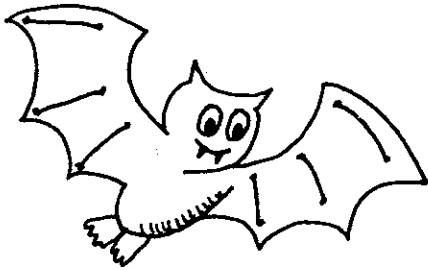

SCHOOL NEWS AND AREA NEWS

FOREST PARK ELEMENTARY

Forest Park Elementary School will hold its annual fall open house on Thursday, October 5-6, 7:30 p.m. This is an opportunity for parents/guardians to visit their children's classrooms, meet their teachers and talk with other parents. There are 385 students in grades kindergarten through fifth at Forest Park this year. The only new teaching staff member this year is Sarah Tudor, second grade.

During the week of October 2-6, third grade students will experience the fall Ohio Reading Achievement Test. The test is part of the State of Ohio's compliance with federal government's "No Child Left Behind" program.

Forest Park Elementary students are observing the Columbus Board of Education approved district-wide dress code policy. Students are not to wear clothing that could compromise their personal safety or the safety of others. Some of the provisions include:

- ◆ Dress length not shorter than mid-thigh and undergarments concealed at all times.
- ◆ Shoes worn at all times.
- ◆ No hats, caps and other type of head covering other than those for religious purposes.
- ◆ No words or writing across the seat of shorts, pants and skirts.

- ◆ Shorts must be hemmed and straight legged, no shorter than mid-thigh and must be worn at the waist.
- ◆ Long pants must be of proper waist size and must not hang below the waist, with pants not touching or dragging on the ground.

Another district-wide policy being followed relates to cellular phones, which may be in the student's possession but are not to be used, seen or heard in school except in a few special situations.

"By working together to improve the school climate, we are taking steps to ensure every child has a great year," explains Fred Tombaugh, Principal.

Interim reports on each child's progress during the first half of the first quarter will go home with students on Friday, October 6. Parents/guardians are urged to read the reports and if they have concerns, contact the teacher to have a personal meeting. The school phone number is 365-5337.

There will be no school on Friday, October 20, Capital Day.
