### FPCA PRESIDENT'S REPORT - FEBRUARY 13, 2007

Thanks again to FPCA Past President Jeff Murray for his service to our community as president for the past two years, and to all of our returning Board members. We welcome and thank those who have joined the Board this year; we look forward to working with you.

Northland HS Walkways: The pedestrian walkways in the vicinity of Northland High School (Tamarack Circle North, Tamarack Circle South, and Denise Drive) have not been maintained for some time and are in serious need of repair. This was mentioned in a Dispatch article (including a photo) on January 9 after a complaint to the paper by a Forest Park resident. Another path apparently intended to serve the high school, between Tamarack Boulevard and Riverbirch Drive North, is in much better condition, but still needs ongoing maintenance. I initiated a conversation with the Columbus Public Schools' grounds keeping manager and with the City (Jim Graham) about this.

Responsibility for the walkways was unclear, as they are not on Columbus Public Schools property. At one point, it was suggested by the City that property owners adjacent to the walkways might be responsible for the cost of repair.

However, last week Jim Graham advised that the City has decided to repair and maintain the walkways. No specific dates for repairs have been set.

NCC Election/Banquet: The election of NCC officers was completed on February 6. Dave Paul, Chuck Parker and Steve Thompson continue to serve as NCC president, VP and treasurer respectively. Roseann Hicks was elected secretary, replacing John Osmond who retired from the position this year.

The 2007 NCC Awards Banquet and inauguration of officers is February 23 at Monaco's Palace. Mayor Coleman, Judge Froehlich (new president of Columbus Urban Growth), several mem-

bers of City Council and other dignitaries will attend. Past President Jeff Murray will present awards from the FPCA to Carol Overfield and to Columbus City Attorney Judge Richard Pfeiffer. Jeff will also accept an award from NCC on behalf of the Moose Riders of Moose Lodge 1427, in recognition of their volunteer work to mulch and maintain the trees on SR-161 east of Cleveland Avenue.

Officer Kevin Grooms, CPD 18 precinct liaison, will be honored with an award by NABA. FPCA will be recognized by NCC as having been represented at every NCC monthly meeting last year, along with two other communities and NCC's Development Committee.

SR-161 Task Force: The NABA State Route Task Force will hold a kickoff event for businesses and communities along the corridor, tentatively named "Network to the Future," at Days Inn Columbus on March 8. In addition to presentations regarding the Task Force and its efforts to maintain the corridor, representatives of City agencies and the Police Division will be on hand to talk about other issues affecting the SR-16 business district (from Worthington city limit east to Ponderosa Drive). FPCA has been invited to have a table and/or representatives there to talk with business owners and managers about possible cooperative projects. Anyone interested in representing Forest Park is asked to contact me.

The Task Force has aligned with the Northland Alliance, and the Alliance has received a commitment of \$50,000 from the City in this year's budget. \$10,000 of this will go directly to the Task Force to help pay for grass cutting and maintenance along the corridor, while the remaining funds will be used to continue outreach to businesses along the corridor and to explore longer term solutions, such as a SID (special improvement district) on SR-161 similar to the one created last year on Morse Road.

Code Enforcement: There has been ongoing discussion and a preliminary meeting between Columbus Code Enforcement and various Northland reps. including Jeff Murray, to talk about CE issues in Northland and elsewhere. The City is exploring options to give CE staff better enforcement powers, including the ability to write citations "on the spot" when violations are noted rather than the current warning process. This is being done in at least one other Ohio city, though there are complex legal issues that may prevent its implementation elsewhere. Discussions continue on the topic and more will be reported

Police Precincts: There seems now to be serious interest on the part of the Division of Police in splitting the 18 precinct (currently the fourth largest in Columbus at over 19 square miles. including the Polaris commercial district) and at least one other CPD precinct (probably the 14, in the Southeast). Such a split has long been advocated by most Northland civic leaders and less seriously considered by CPD. Forest Park is wholly contained within the 18 precinct (and makes up most of the 180 and 186 cruiser districts). Northland civic leaders have met with CPD informally to discuss this possibility. More on this as it develops.

Club Obvious: Club Obvious, in the Raintree Plaza at SR-161 and Cleveland Avenue, closed on January 19 after another shooting at that location. A new business, "Sharks Bar Continued on page 4)

#### F.P.C.A. BOARD MEETING MINUTES - JANUARY 9, 2007

The meeting was called to order by Jeff Murray at 7:10 p.m. at Epworth United Methodist Church. The minutes from our last meeting were approved unanimously. All board members were present, except Mark Bell and Paul Miller who were excused.

The Treasurer's Report was given by Kirsten Crilley. We ended last year right on budget. The report was unanimously approved.

Jeff Murray gave the President's report. The shrubs have been removed from the west island. We look at removing two trees from the east island next year. The budget was approved for 2007. Included in the budget is new signs for the island. The NCC banquet will be February 23 at Monaco's Palace. The cost is \$25.00. The police department is considering splitting our precinct because it is so large. The hourly rate went up for our supplemental security officers to \$35.50 per hour. Businesses in our area need our support. Woods has installed decorative street lights on Sharon Woods Blvd, and Beechcroft. If any residents looked at these and thought it was something they wanted, we might pursue another petition. The Morse Road project is done from Indianola to Karl. Work will start in 2008 for Karl Road to Cleveland Avenue. The 161 Task Force has been formed to keep 161 looking good.

George Schmidt, Past President, called for nominations for officers for 2007. The new officers were sworn in by Richard Pfeiffer.

Dave Paul took over as President. He nominated Earl Miller as our official photographer.

Dave Kienzel gave a report on security. The 2006 report included 66 home checks, 15 arrests, 4 domestic violence, 10 disturbances, 33 traffic tickets, 3 stolen cars and 4 burglaries.

The membership report was given by Dave Paul. A total of 919 residents joined which is 34% for a total of \$18,580.

Arline Ries gave a report on the Forester. The Forester will be delivered on the first weekend of the month.

Lyn Denney gave the NCC report. Officers were nominated. Clinton Town-

ship wants to be a member of Northland Community Council. Jeff Murray gave a report on development. A church asked for a parking variance at Schrock and Cleveland. An approval was given for condos at Ulry and Central College.

Dick Buttermore reported on civic action. Forest Park Elementary has a traffic problem with parents dropping off and picking up their children.

The Block Watch report was given by Dave Paul. A total of 115 households have joined. FPCA is thinking about consolidating with Sharon Woods.

Some comments from area representatives include: Mike Stone commented on property maintenance. Bob Hinebaugh has a problem with barking dogs. Valerie Orr has a problem with cats being tuned loose. Kit Race has a problem with Northland High School children. Dennis Durham has a problem with litter.



This is a new proprietor, apparently the owner of a Short North restaurant who wants to open a Northland location. Application has been made to transfer the liquor license; the business can operate while the application, to which the City has filed a new objection, is pending. We are told they intend to operate as a "real" restaurant and bar, not as a club. The City Attorney has assured me they will have police keep an eye on the location to avoid similar issues as occurred

Olive Garden: We have learned that Darden Restaurants is planning to relocate the Olive Garden from SR-161 near Parkville in March 2008 to a new building at Cherrybottom and Morse Road. While this is a loss to SR-161, we are glad they plan to remain in the Northland area. The Task Force plans to be involved as it can in the search for a new tenant for the Olive Garden prop-

We are discussing this with the leaders of those groups. - Charlene and Jerry, fellow Forest Park residents, who rented us their ready to sell

home and who handed us the keys just three days after we spoke.

- Charlene's sister, Barbara, another of our fellow FP residents, who rallied the Forest Park troops on our behalf,
- Dave and the Civic Association for your understanding and your plea for help on our behalf, you called, you organized, you cared,
- Joe and the Charity Newsies for your generous gifts of clothing and shoes,
- Fran, Julie, Lela and Al who called Dave and offered everything from toys to a computer to clothes to any thing we needed, we say thanks!

To all of you and to those whose names we don't know, all we can do is say thanks, and honor your generosity by leading lives of gratitude as best we can by teaching our children to be grateful and to give back. This we intend to do!

Once again we say thanks to each of you for your patience and under-

standing as we await the completion of construction and restoration. Just to update you, the city permits have been secured, de-construction and cleaning are underway and repair and construction of the interior damage should begin soon. We hope to be back in our house sometime during the spring.

Just one last plea, our family cat, Whiskers, a chubby yellow tabby cat, made it out of the fire alive. He has been content to stay at the house since the fire as we went by to feed, water, and love on him every day. Shortly after Christmas, he disappeared. If you might have picked him up to give him a good home, I assure you he has been loved and well cared for. Our garage is open for him and he has a warm, insulated, well bedded igloo inside, as well as extra food and water. If you perhaps picked him up, we appreciate your love and concern for him, but hope you will return him to us. The loss of our cat was a deep sorrow for our family! 

I am a life long resident of the Columbus area, and never have I felt welcome anywhere as I have in Forest Park. Thank you to whomever plowed my driveway that day and thank you to the Forest Park neighbors that have made me feel so welcome.



- 6 If you are scheduling for bulk collection within an apartment complex, items need to be placed at the designated collection point for your apartment community. If you are unsure of the exact location, please contact your leasing office or property manager.

- 8 Items resulting from an eviction or foreclosure will not be collected.


