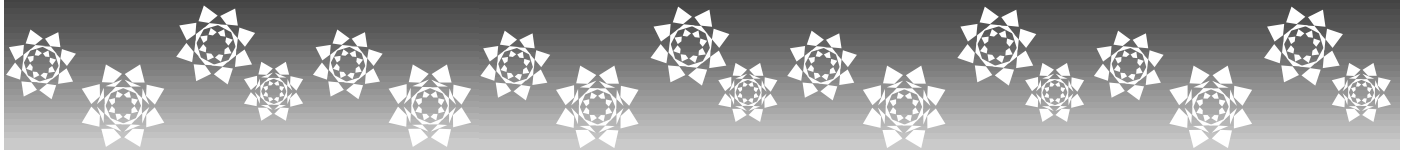
## Presidents Letter by George Schmidt

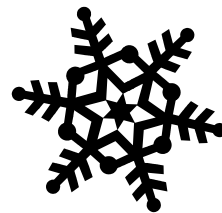
