FOREST PARK CIVIC ASSOCIATION GENERAL MEETING APRIL 10, 2012 By Carol Overfield

The meeting was called to order by President, Mike Stone, at 7:00 at the Epworth Methodist Church. The minutes of our last meeting were presented and approved. The Treasurer's report was presented by Dan Hartzell and approved.

Rick Pfeiffer and Bill Sperlazza from the City Attorney's office were present. The city is divided into 5 zones. There is a law-yer for each zone. We are zone 1. To report a problem or contact any city agency call 645-3111. The city attorney's office can also be contacted at columbuscityattorney.org. Bill Sperlazza can be contacted at 645-7479. The Attorney's office is working on closing the adult entertainment establishment, Club Escape, on 161. There is a problem with maintenance on foreclosed houses. The homeowner is responsible until the bank takes ownership even though the homeowner is no longer living there. Code enforcement should be called if there is a problem on private property; the police department if a problem is on public property.

Dick Graham, our neighborhood liaison officer, answered some questions. He can be reached at 645-7371.

Ed Vanasdale gave a report on security. There has been one house check each month in March and April. There was a problem reported with barking dogs on Walden.

Applications for membership were mailed last week. They are starting to come in. Outreach day will be July 21.

Susan Buttermore gave a report on the Forester. The deadline for next month's issue will be April 19. She will put the house check form in each issue all summer.

Ken Gilbert gave a report on the NCC meeting. Each neighborhood will get 2 free signs for the bicentennial. We will have to decide where to put them. The Northland Plan will be updated in the near future. Participants are needed. April 21 is cleanup day on 161. May 12 is shredding day. The location will be announced later.

A report on the 50th anniversary celebration was given by George Schmidt. We have gotten a \$5500 grant from GCAC and Chase Bank. Framed pictures will be on display somewhere in the fall. The banquet will be May 17. Tickets are \$10. The Y Service Club will serve the dinner. Patrick Alkire will pick up anyone who doesn't want to drive. We are in the process of getting sponcers door prizes. Outback Steak House is providing the food. The choices will be steak, chicken or a vegetarian dish.

George had a meeting with the Tamarack Circle business owners. They are trying to work together to clean up Tamarack Circle.

Fran Ryan will be the Grand Marshall at the 4th of July parade.



When the message starts press "Star" to be directly connected to an operator to give your information. If we report these unlicensed salesmen, they will leave our neighborhood and probably not return. If you have a concern of a stranger or something going on in the neighborhood, please, call the police first at the 645 number as they will be able to respond to your matter. If you would like me to follow up on this, call me and leave a message with your name, phone number, and a time to best contact you.


I am embarrassed by my stupidity, but you can pass along this alert in your words (or mine) if you wish.

April 19, 2012 City of Columbus 200 Celebration at the Gillie Center History of Northland By George Schmidt

Imagine Congress passing bill like this today. "An act regulating the grants of land appropriated for military services and for the Society of the United Brethren for the propagating of the Gospel among the heathen." It was passed June 1st 1796. It was a way to pay soldiers for their service in the Revolutionary war.

James Harrison was one such soldier. The best I can tell, and this is an educated guess, James Harrison was a Colonel who had some distinction at Gettysburg. "There is granted unto James Harrison, a tract of land containing 4,000 acres, being the 4th quarter of the 2nd township in the 18th Range of the tract appropriated for satisfying warrants for military service." Signed by the president, John Adams, and countersigned by Charles Lee, then executing the office of Secretary of State, on the 16ht day of May, 1800. Sealed! This is now what most of the NCC area composes.

In 1868 this land was the site of a 19th century soap opera. Margaret Thompson, widow of Thomas Thompson died leaving this section in probate. The land was to be divided between all the heirs. There were 58 named in the case. There was murder, some 60 arrests. The court decided the land should be sold and the money divided. The youngest payee was 4 years old.

There hundreds of transactions over the years involving scores of banks as sections were divided and joined again.

Little towns began to be built in the center of farms of all sizes. Then the boom to the north side of Columbus in the late 20th century happened. In 1961 when the Metzger brothers began building Forest Park, part of Woodward Park and Carmel were built. There was an airport, country club and golf course along Morse Road.

Forest Park was built as a model community. I have the original sales packet here. There were 19 separate builders each with their own style of house. The community was centered with a shopping center, swimming pool and community park. This model was so popular that thousands of communities around the country copied it.

In 1962 eight people met at Hi Timbers on Morse Road and started the Forest Park Civic Association. The Metzger Brothers helped even thought they knew the group was going to work against them at times. For instance the association was against apartments.

There was soon a need for an organization to handle the ever growing community. Areas like Sharon Woods and Devonshire now a reality in 1963 there was a need to control was being build. So in 1964 the Northland Community council was formed. Bob Preston the first president said they had to deal with such issues as the widening of 71. They were initially opposed the building of Northland Mall.

In 1980 a lot of attention was devoted to the development of St. Ann's Hospital and Meijer. In 2004 Dominion Homes brought forth a plan to build houses on Minerva Golf Course.

For two straight years Northland High School won the nation STEM contest. The Northland area has always been a great asset to Columbus. Many are still dedicated to preserving the vitality of the strong neighborhoods that make us up. We are pushing back the forces that would decay. We are winning.
