

Community Shelter Board to make sure everyone is on the same page with the housing of folks who have had to leave complexes that have been closed. They are continuing to work on hotel issues in our area. The Library is currently holding the Summer Reading Program. There is a book tasting event at Karl Rd Library on July 13 and a book festival at the downtown location July 13 and 14. The Northland Business Association quarterly lunch took place at Elevate Northland. Council Member Wyche was the speaker. He covers Northland north of 161. We had a guest speaker for our community liaison. Rebecca Deeds of the city spoke on new transit proposals and new dedicated bus service. It was also noted that a discussion of the city's Capital Improvement Budget for next year is accessible on YouTube.

Kelly Messer, Project Manager from Columbus Recreation and Parks spoke about the soccer park being built on Westerville Rd., between 161 and Morse. It's a renovation of the old fields and an expansion and it looks like a solid addition to Northland. The usual reports from Council leaders were made. Columbus City Council gave public recognition to the Northland Fourth of July Parade.

Finally, the NCC will have it's annual cookout at Blendon Woods Metro Park on August 13 (this replaces the usual FPCA meeting). ALL in the community are welcome. #### When you come back from vacation and .....

This was a brutal June and July.

The gardens looked in great shape when I left on vacation at the beginning of July, what the heck happened? I do need to thank my neighbor who diligently watered my container plants. If not for her, I would have come back to a real heartbreak. It seems like the only green things I have left are the weeds.



So, it has me thinking, as I get closer to my retirement date, and want to travel more, how do we manage the gardens that Tim and I have created over the years to not be a "crap ton" of work when we get back from our adventures.

I believe that our weather trend is not going to be reversing any time soon. It's time to add some Xeriscape elements to the garden – especially out front where I get full sun. Xeriscaping involves the use of plants that need very little water and are heat resistant. Most of these native plants you already know.... Lavender, Rudbeckia (Black eye Susan), Coneflower, and many sages and grasses.

Did you know that approximately 40% of a household waterbill is used for lawn irrigation and gardens? Xeriscaping can save around 50% of outdoor water usage, which can add up to some significant savings, especially in summers like this one.

I'm not interested in making my property look like I live in a desert (ie: replacing my entire lawn with pea gravel), but I'm going to be careful what perennials I decide to plant this fall. I am also NOT going to replace anything that died this summer. That includes my beloved Rhododendron that I have babied for the past 4 years. I'm sad, it's dead, moving on.
