

Cyber security expert provides tips to stay safe

Mark Bell, our FPCA Area 13 Representative and Forest Park East resident, delivered a helpful presentation on cyber security at the FP civic association's October meeting. October was Cybersecurity Awareness Month in Ohio. Mark is the Cyber Security Outreach Coordinator at The Adjutant General's Department of Ohio. The Adjutant General has responsibility for the Ohio Army National Guard, the Ohio Air National Guard, the Ohio Naval Militia and the Ohio Military Reserve. Mark is also the Chair of The Ohio Cyber Range Institute (OCRI), a cybersecurity partnership of state government entities.

Mark provided a list of recommendations to keep your home computers and networks secure. He advised Forest Park residents to take a three-step process for home cyber security: inventory all your devices; protect your devices; and detect cyber threats on your devices.

Mark provided the following tips for Forest Park residents:

- 1. Update your operating system (OS) and programs to the latest versions available, including Windows and Microsoft Office.
- 2. Delete old or unused programs.
- 3. Change the default usernames and passwords on hardware and systems that you buy, including routers and video doorbells.
- 4. Use strong passwords and multi-factor authentication (MFA).
- 5. Activate and use firewall and antivirus programs.
- 6. Backup your data every day on a cloud service or backup drive. If you use a physical backup drive, disconnect it from your computer when not in use. Use encryption for sensitive data.
- Create separate guest network accounts (VLANs) on your wi-fi and other networks for visitors, Internet of Things (IOT), wireless devices, Kids' accounts, old tech, and main computers (segmentation).
- 8. Inventory your network and block unknown devices.
- 9. Beware of links in emails and web pages. Look up and verify the link and type it in.
- 10. Beware of email attachments.
- 11. Beware of public wi-fi networks.
- 12. Beware of thumb drives, CD-ROMs, and other external devices.
- 13. Protect your physical computers and phones to prevent others from accessing or stealing them. Lock your screen on computers, phones and other devices when not in use.
- 14. Be careful when posting on social media. Photos can include Personally Identifiable Information (PII), such as the location where the photo was taken.

Hello Forest Park!

Happy Holidays! Nighttime starts at around 5:30pm and will keep coming earlier until the Winter Solstice, which leaves a lot of time for darkness. Do yourselves and your neighbors a favor by keeping your porch light on during the night and wearing reflective clothing when you're walking about. People breaking into vehicles continue to be an issue so don't leave any valuables in your car and keep your car locked when unattended. Do not leave your car running in the morning whether in your driveway or in a parking lot. That is the easiest way to have your vehicle stolen and is illegal.

Discharging a firearm within city limits is a crime. If you hear what you believe to be gunfire, please report it to the police, not Supplemental Security, and provide as much information as possible. If it's an event that you are thinking of after the fact, you can still report it to the police non-emergency line, at 614-645-4545, because the information that you give could help them narrow down a location and find a shooter. Do not contact our police liaison directly with the information as he is usually away from his desk and out on patrol and therefore unable to respond timely.



We continue to receive a lot of reports of speeders through the neighborhood. This is

dangerous for many reasons and made more dangerous with the short days and kids about. Please learn the posted speed limits and other traffic rules and follow them. They may seem like an inconvenience, but things like where you can and cannot turn on red, where u-turns are allowed, proper parking procedures, and the posted speed limits are in place for specific reasons, namely safety.

There have also been reports of open fires in Woodward Park. Police investigated the reports but did not find evidence of the fires but if you notice this happening, please notify the Columbus Fire Department immediately and the arson division will respond. We had an unusually dry summer and there are a lot of dry leaves on the ground, which poses widespread fire risk.



As Thanksgiving approaches, we are so very grateful for the neighborhood we live in and the comradery we share with our neighbors and the fellow Civic Association members. If you're a paid Forest Park Civic Association member, keep those house check requests coming, but also be sure to get out and meet your neighbors because they can be some of your best resources for keeping yourself and the neighborhood as a whole safe. This is especially important as new neighbors come to the area.

Code of Conduct adopted at November 2024 FPCA meeting

BYLAW XX CODE OF CONDUCT FOR OFFICERS, COMMITTEE CHAIRS, AND AREA REPRESENTATIVES

The Forest Park Civic Association (FPCA) has adopted the following Code of Conduct that all members in leadership positions (Board members, Chairpersons, or Area Representatives) agree to adhere to.

1.) Prohibition Against Private Inurement and Procedures for Managing Conflicts of Interest

No member in a leadership position shall derive any personal profit or gain, directly or indirectly, by reason of his or her service as a member with the Forest Park Civic Association. Members shall conduct their personal affairs in such a manner as to avoid any possible conflict of interest with their duties and responsibilities as members of the FPCA. Nevertheless, conflicts may arise from time to time.

- a) When there is a decision to be made or an action to be approved that will result in a conflict between the best interests of the Forest Park Civic Association and one's personal interests, the member has a duty to immediately disclose the conflict of interest so that the rest of the membership's decision making will be informed about the conflict.
- b) It is every member's obligation, in accordance with this policy, to ensure that decisions made by the Association reflect independent thinking. Consequently, in the event that any member receives compensation from Forest Park Civic Association such compensation will be determined by and approved by the full Board of Trustees in advance.
- c) Any conflicts of interest, including, but not limited to financial interests, on the part of any member, shall be disclosed to the Board of Trustees when the matter that reflects a conflict of interest becomes a matter of Association action, and through an annual procedure for all members to disclose conflicts of interest.
- d) Any member having a conflict of interest shall not vote or use his or her personal influence to address the matter, and he or she shall not be counted in determining the quorum for the meeting.
- e) All conflicts disclosed to the Board of Trustees will be made a matter of record in the minutes of the meeting in which the disclosure was made, which shall also note that the member with a conflict abstained from the vote [and was not present for any discussion, as applicable] and was not included in the count for the quorum for that meeting.
- f) Any new member will be advised of this policy during orientation and all members will be reminded of the Code of Conduct and of the procedures for disclosure of conflicts and for managing conflicts on a regular basis, at least once a year.
- g) This policy shall also apply to any member's immediate family or any person acting on his or her behalf.

2. Prohibition Against Sexual Harassment

The Forest Park Civic Association strives to maintain an environment that is free from illegal discrimination and harassment. While all forms of harassment are prohibited, it is the organization's policy to emphasize that sexual harassment is specifically prohibited. Any member who engages in discriminatory or harassing conduct towards any individual is subject to removal from their position. Complaints alleging misconduct on the part of members in leadership positions will be investigated promptly and as confidentially as possible by a task force of the Association appointed by the Executive Board.

3. Confidentiality

Members are reminded that confidential financial, personnel and other matters concerning the organization, donors, staff or clients/consumers may be included in Association materials or discussed from time to time. Members should not disclose such confidential information to anyone.

4. Active Participation

Members in leadership positions are expected to exercise the duties and responsibilities of their positions with integrity, collegiality, and care. This includes:

- Making attendance at all meetings of the Association a high priority.
- Being prepared to discuss the issues and business on the agenda, and having read all background material relevant to the topics at hand.
- Cooperating with and respecting the opinions of fellow Association members, and leaving personal prejudices out of all Association discussions, as well as supporting actions of the Association even when the member personally did not support the action taken.
- Putting the interests of the organization above personal interests.

Representing the organization in a positive and supportive manner at all times and in all places.

Showing respect and courteous conduct in all Association and committee meetings.

Refraining from intruding on administrative issues that are outside the scope of the elected role, except to monitor the results and ensure that procedures are consistent with FPCA policy.

Observing established lines of communication and directing requests for information or assistance to the Executive Board.
